

# **Workshop Bioeconomy**

#### **Background and challenges**

MOST and BMBF have already conducted three very successful joint calls for proposals and are willing to prepare a fourth one.

The workshop could be used (1) to discuss about possible topics for that call and (2) to connect scientists of these topics as a matchmaking event.

## Aims of the Workshop

In this workshop relevant stakeholders (scientific experts and persons from funding organizations) from both countries shall be brought together – especially people that are already experienced in German-Vietnamese cooperation.

After the presentation of some examples of successful cooperation projects, a discussion round will be initiated. The aim is to talk about "lessons learned" and suggestions for improvements (also with regard to the funding instrument "Bioeconomy International"). Finally, a concrete subject of discussion shall be another upcoming joint call in Bioeconomy of MOST and BMBF. In that regard an exchange of needs of concrete topics which are important for both countries shall be discussed.

#### Key-questions for in-depth discussions in the workshop

- Given the typical restrictions of project funding, e.g. a maximum duration of 36 months, in which thematic areas do you see the greatest relevance / a concrete need for research for both countries?
- Where do you expect the highest impact / greatest synergies to be achieved?
- Where do you see the problems / difficulties / barriers in bilateral cooperation?

- Scientists of already funded projects
- Not-yet-funded-scientists in the area of the suggested topics
